Westbound: Regular route to Bear Valley Rd and Central Rd then continue via Central Rd to L) Ottawa Rd, R) Quinnault Rd to temporary bus stop NS Powhatan Rd.

Eastbound: From Quinnault Rd & Powhatan Rd, R) Powhatan Rd, R) Central Rd to regular route.

Route 40

Southbound: Regular route to Pawnee Rd and Outer Highway 18 North then R) Outer Highway 18 North, L) Navajo Rd, L) Ottawa Rd, L) Quinnault Rd to temporary bus stop NS Powhatan Rd.

Northbound: From Quinnault Rd & Powhatan Rd, L) Powhatan Rd, R) Navajo Rd, R) Outer Highway 18 North, L) Pawnee Rd to regular route.

Route 41

Eastbound: Regular route to Highway 18 and Navajo Rd then continue via Navajo Rd to L) Ottawa Rd, L) Quinnault Rd to temporary bus stop NS Powhatan Rd.

Westbound: From Quinnault Rd & Powhatan Rd, L) Powhatan Rd, R) Navajo Rd, L) Outer Highway 18 North to regular route.

Route 43

Eastbound: Regular route to Powhatan Rd and Navajo Rd then continue via Powhatan Rd to temporary bus stop FS Quinnault Rd.

Westbound: From Powhatan Rd & Quinnault Rd, via Powhatan Rd, R) Central Rd to regular route.

Route 47

Northbound: Regular route to Yucca Loma Rd and Navajo Rd then continue via Navajo Rd to L) Ottawa Rd, L) Quinnault Rd to temporary bus stop NS Powhatan Rd.

Southbound: From Quinnault Rd & Powhatan Rd, L) Powhatan Rd, R) Navajo Rd, L) into old Carl's Jr parking lot to L) Yucca Loma Rd to regular route.
