- A1: Yes, with the exception that the existing charging stations in Hesperia will need to be paired and existing mounting brackets need to be replaced.
- Q2: "Need clarification on the cement pathway at the Hesperia facility."
- A2: The Scope of Work explains the need for a pathway from the edge of the outer planter leading to the charging station. Pictures are in the RFP to assist with the visual.
- Q3: "For Barstow, where will the disconnect be located?"
- A3: VVTA Staff will contact Edison to clarify the location of the disconnect. This will be information with be provided to the awarded contractor.
- Q4: "For Barstow, will VVTA be providing the "Bollards?"
- A4: Yes, VVTA has the Bollards.
