

Ratify the Creation of a Temporary VVTA Public Route, Vaccine Xpress (VX).

SUMMARY STATEMENT

This free public route will connect our senior passengers to a COVID-19 Vaccine Center hosted by the City of Victorville. Service will commence on Wednesday, February 10, 2021, between the hours of 10:00 AM to 6:00 PM. The express service will continue for up to six (6) months, Tuesday through Saturday and will operate between Lorene and 7th and the Hook Community Center, located at 14973 Joshua St Victorville, CA 92394 with no stops in between. In order to facilitate transportation to and from the vaccine center, staff proposes the creation of Route VX Vaccine Xpress which will be free to the public during the duration of the service. The cost of the service will be funded from a FEMA COVID-19 grant which will cover 100% of the cost.

Schedule Beginning February 10, 2021

Vaccine Xpress

Operating on a 30-minute schedule

10:00 AM to 6:00PM

This is a public route meeting the requirements of FTA and is not considered a "Charter". As such, staff will prepare a public route map and schedule.





