This addendum is provided to all known prospective proposers for clarification of the subject Request for Proposal (RFP).

The following were questions posed during the job walk on 09/12/2022 and the answers from VVTA staff. The last day for questions was on 09/23/2022 and no questions were received:

Q1: "Will we be doing any work in the Server Room?"

A1: No

Q2: "Are we painting the ceiling or ventilation in the Maintenance Building?"

A2: No

Q3: "Will the Oil Pit need any work done, in the Maintenance Building?"

A3: Not flooring, but we do need the area to be painted.

Q4: "The system and steps for the epoxy and/or resin were not included in the RFP. Is there a preferred system?"

A4: Because this is a Request for Proposal, we ask the Proposers to provide the system the Proposer deems to be the best solution for VVTA.

Other items to consider:

- The awarded contractor shall provide to VVTA sample colors/styles for the epoxy flooring to be installed in the office areas and stair wells.
- VVTA asks that proposers propose on a material that may be more durable and resistant
 to heavy foot traffic while still providing ease of access underneath the flooring for the
 carpet and marmoleum in Building A. VVTA will need to access the HVAC system that
 is beneath the floors throughout the building.
