SUMMARY STATEMENT

VVTA has experienced some unexpected and important matters which arose from the recent Executive Director search conducted by Transit Pros, LLC. With the imminent retirement of the current Executive Director, it is in VVTA's best interest to appoint an Interim Executive Director.

Staff recommends appointing Nancie Goff, Chief Operating Officer as the Interim Executive Director as of January 1, 2023, ending upon the start date of VVTA's new Executive Director. Ms. Goff is the longest standing employee of VVTA, having been with VVTA since 1994 and has agreed to accept this Interim appointment, if the Board so chooses.
